SE) Department, Government hereby accord administrative sanction for an amount of Rs.211,63,00,000/ (Rupees Two Hundred Eleven Crores Sixty Three Lakhs only) from B.E.2012-13 under Plan Scheme towards Construction of Kitchen Cum Store Rooms under Mid Day Meal Scheme in relaxation of Quarterly Regulation orders.
- 4. The amount sanctioned in para 3 above shall be debited to the Head of Account as mentioned in Budget Release Order in the reference second read above.
- 5. The Commissioner and Director of School Education, Andhra Pradesh Hyderabad shall take necessary action and furnish the Utilization Certificates.
- 6. The Commissioner and Director of School Education, A.P., Hyderabad is further informed that the balance of Central & State share will be released after exhausting BE 2012-2013 provision released.
